APPLICATION DATA

SURFACE PREPARATION

Surfaces must be thoroughly clean before application. Remove any loose dirt, gravel, oil, loose paint, or foreign material. Patch large holes or surface cracks with an asphalt compound or concrete patch. Do not apply to wet surfaces or at temperatures below 50°F (16°C).

APPLICATION METHODS

Brush, roller, line marking machine, or spray (conventional and airless equipment).

APPLICATION EQUIPMENT

Brush: Polyester or nylon brush.

Roller: Use ½" nap roller cover or larger.

Marking Equipment:

Airless Spray and Conventional Spray: Non-specialized spray equipment in a wide range of sizes and types can be used.

VISCOSITY

88-93 K.U. Krebs-Stormer Viscometer

THINNING

Thinning is not necessary; however, a small amount of water can be used to achieve proper spraying consistency.

DRYING TIME

77°F (25°C) and 50% relative humidity

To touch: 10 to 15 minutes*

No Tracking: 60 minutes

*This condition does not mean that the paint film has reached full cure; handling can be achieved without loosening, wrinkling, or otherwise marring the film under minimal pressure from fingers or hands. Drying times listed may vary depending on temperature, humidity, and air movement.

RECOMMENDED WET FILM PER COAT

Marking Machine: 15 mil
Brushing: 6 mil
Sprayed: 12 to 15 mil

RECOMMENDED DRY FILM PER COAT

Spray and Marking Machines: 6 to 7 mils
Brush: 3 to 4 mil.

RECOMMENDED SPREADING RATE

This material will cover 350 linear feet per gallon with a 4-inch line or 250 square feet per gallon.

CLEANUP

Best results use soap and warm water.

5-gallon (18.9 L) containers
55-gallon (208L) drums

FLASH POINTS

Water based formula.

Greater than 200°F (93°C) Pensky-Martens.
